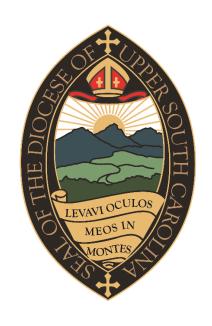

# NORAH GRIMBALL BIOGRAPHY

# Dr. Norah T. Grimball, Trinity Cathedral, Columbia

Dr. Norah T. Grimball is a life-long Episcopalian and a member of Trinity Cathedral where she currently serves as a Worship Leader, Chair of the Hospitality Ministers, Chair of the Eucharistic Ministers, Chair of the Finding God's Path Ministry, member of the Needlework Guild, and a recovery coach in the Family Recovery and Support Ministry. Previous Cathedral service includes Dean Search Committee, Junior and Senior Wardens, Vestry, Finance Committee, Diocesan Convention Delegate, Eucharistic Visitor, Pastoral Care Team Chair.

On the diocesan level, she serves as Secretary to Diocesan Convention, a Deputy to General Convention (2015, 2018, 2022), member of the Commission on the Episcopal Church and the Anglican Communion, the Commission on Ministry, the Commission on the Diocese and the Bishop Search Transition Committee. She previously served on DEC/Standing Committee (Secretary) and as Chair of the Resolutions Committee, Chair of the Bishop's Interview and Discernment Committee, Co-chair of the Commission on Ministry of the Baptized, and Communications Chair of the Bishop Search Committee. She is also a spiritual director.

Dr. Grimball has worked primarily in the field of adult education, including several years as Director of Education and Training for the Computer Services Division at the University of South Carolina. For 28 years she was employed by Teradata Corporation (formerly NCR) where she was a manager in the Training Division, responsible for development and delivery of training to a global audience as well as facilitation of crossfunctional teams, workshops, meetings and conference calls. She is a graduate of the University of South Carolina (B.A.), Ohio State University (M.S.), and Graduate Theological Foundation (D. Min.). She holds a certificate in Spiritual Guidance from the Institute for Spirituality at Palmetto Health and has also completed Sewanee's Education for Ministry program.

# WILLIAM R. SANDBERG (Bill)

St. Timothy's Episcopal Church, Columbia

I would welcome the opportunity to serve as the Diocesan Treasurer. My church experience has prepared me through a combination of work at the parish, convocation, and diocesan levels; my education (particularly in finance) and professional service as a management professor at the University of South Carolina add relevant skills.

A Desire to Serve. I long have believed that EDUSC's future depends critically on its congregations' capacity to revitalize themselves rather than to accept gradual decline. Service on DEC and as its President and on the Commission on the Diocese and the SOM Committee has opened my eyes to the broader challenges and opportunities facing EDUSC.

Our Diocese must use its resources wisely to strengthen the parishes and missions in their efforts to carry out EDUSC's vision, while recognizing that the Diocese's financial resources flow primarily from its congregations. Stewardship of those resources includes improving our budgeting process through clearer and more complete communication, developing and adhering to financial policies and procedures that meet auditors' standards, and encouraging multi-year planning for financial needs.

I bring those perspectives as well as useful experience and professional skills plus a commitment to the imperatives of the Church and our Diocese. I feel called to offer my service to God through EDUSC and pray that it will be accepted.

*Experience and Skills.* In addition to EDUSC (see above), I have served parishes through vestry and church council leadership, involvement in adult and children's Christian Formation, and choir membership. Three rector's search committees (and seemingly countless faculty search committees) as well as deep involvement in strategic planning and budgeting in parochial, university, and business settings round out my experience. A Ph.D. in Management Policy and M.B.A. and undergraduate degrees in Finance have equipped me with concepts and skills that are helpful in such roles.

### The Reverend Scott Fleischer



The Rev. Scott Fleischer has served Episcopal parishes and institutions throughout South Carolina since his ordination in 2002. These include Prince George, Georgetown; York Place, York; St. John's, Columbia; and Christ Church, Greenville, where he presently serves. His diocesan service includes being Dean of the Midlands Convocation (2019-2021), Deputy to General Convention, Salt Lake City (2015), member of the Diocesan Executive Council (2013-2016), and Secretary to DEC. He also served on the Bishop's Executive Committee, was a member of the diocesan Commission on The Episcopal Church and National Concerns, a member of the diocesan task force for Confirmation, spiritual director for Happening, leader of a diocesan mission trip to Ecuador, and

member of Kairos teams. Scott and his wife, Victoria, have raised three children and now enjoy being "empty nesters." He likes to jog the Swamp Rabbit Trail and read historical fiction novels in his free time.





The Rev. Deacon Dianna LaMance Deaderick is a deacon in the Episcopal Diocese of Upper South Carolina (EDUSC) assigned to St. Martin's-in-the-Fields, Columbia, after serving nearly eleven years as the deacon at St. Luke's Episcopal Church in Columbia, SC. She is a retired National Board Certified Teacher and received a BA in elementary education from Berea College in Berea, KY, and an MA in family literacy from the University of South Carolina.

While at St. Luke's, Deacon Dianna was instrumental in the church being recognized by the National Episcopal AIDS Coalition as the first HIV/AIDS Welcoming Parish in the country. She was also the founder and the Executive Director of



the Fresh Start Ministry, an outreach ministry of St. Luke's which provides free laundry services, showers, food, clothing, free HIV testing and basic health screenings to those of us living in poverty in the Historic Waverly Neighborhood of Columbia, which began in October 2016.

### The Reverend Beth Hendrix



The Rev. Beth Hendrix is a 2021 graduate (M.Div.) of Virginia Theological Seminary. Originally from Columbus, Ohio, and raised in North Augusta, SC, Beth is an avid golfer, loves history, and is passionate about serving persons with cognitive impairment and varied physical abilities. Prior to seminary, she served her parish (Senior Warden, Christian Formation Director, Communications), EDUSC (Long Range Planning committee and DEC member during Bishop Henderson's episcopate, DYLC Event Planner, Secretary of Diocesan Convention, and the Commission on the Diocese during Bishop Waldo's episcopate), and Gravatt Camp and Conference Center (Board of Trustees). Beth is active in the Companions of the Center for Anglican

Communion Studies, a membership society for individuals, parishes, dioceses, and institutions seeking to connect with CACS programs supporting a reconciling, intercultural Anglicanism. She has two sons, Preston and Tenison. Her mother, Nancy, and brother, Frank, live in Central Florida.

The Rev. Raphiell Ashford is the twenty-first rector at St. Luke's Episcopal Church, Columbia. Fr. Raphiell was born and reared in Kosciusko, MS. Fr. Raphiell served as an Army medic in the U.S. Army and, upon receiving an honorable discharge, worked in numerous fields prior to entering seminary. Fr. Fr. Raphiell earned his M.Div. from the Virginia Theological Seminary in Alexandria, VA, in 2017. Prior to arriving at St. Luke's in October 2019, Fr. Raphiell served as priest at St. Christopher's Episcopal Church of the Ascension in Jackson, MS. In addition to this, his duties also included serving as the Diocesan Missioner—serving as a supply priest for two churches without a priest, St. Mary's Episcopal Church, Vicksburg, and All Saints' Episcopal, Jackson.

Since his arrival in Columbia, Fr. Raphiell has spent the majority of his time leading his parish through the pandemic. He is also getting more familiar with the city, especially the Waverly Community, where St. Luke's is located.

Fr. Raphiell is active in the diocese and larger Church community. He recently served on the Bishop Nominating Committee which was responsible for presenting a slate of candidates to the Standing Committee for consideration to serve as the 9<sup>th</sup> Bishop of the Episcopal Diocese of Upper South Carolina.

Fr. Raphiell is a trained musician having served as the church organist, pianist and choirmaster at St. Mark's Episcopal Church (Jackson, Mississippi) and pianist/organist at the First Missionary Baptist Church (Kosciusko, Mississippi). # Ms. Christine (Chris) Wood Lynn



I was born in Kinston, NC, and moved to Spartanburg in 1973 to attend Converse. After graduation, I worked for United Way, Converse, and St. Paul's Catholic School. I married in 1980, and my husband Maxey and I have two adult children and three perfect grandchildren. We are both retired now and enjoying more time to travel and to do the volunteer work we enjoy.

My husband and I were confirmed at the Advent in May of 1989. When I looked into Bishop Beckham's eyes as he helped me to stand, I knew I was home. I immediately got involved by going on a mission trip that summer to York Place and found a group of youth and adults who became immediate and lasting friends.

Later that summer, I was asked by a member of the Vestry to be the "part-time, temporary DCE until we can find a rector who will hire someone who knows what she's doing." With that ringing endorsement, I embarked on a new adventure. During my twenty-one-year tenure with the parish (the rector apparently couldn't find anyone who knew what she was doing), there were many mission trips, pilgrimages, continuing education, and many conferences. I created a curriculum for Leader Resources and was a consultant for several parishes in the Southeast, from Richmond to Little Rock and Greenwood. In addition, I spoke at a Children's Ministries of America Conference and two FORMA conferences.

I was asked to serve on the Christian Formation Commission of the Diocese, where I got to know Phil Purser and some of the world's finest people. We did teacher training for small parishes and offered two conferences at Gravatt. At that time, there was a wonderful resource library at the diocesan house, and we all contributed to making that happen. In 1996, I became involved with Safe Church and offered too many trainings to count. Eventually, I trained the trainers and worked on the curricula to adapt them to one three-hour class.

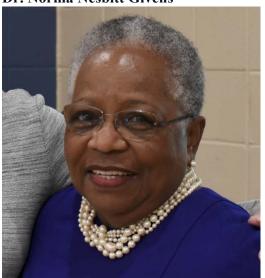
After attending several Christian Formation conferences at Kanuga, I started volunteering for that particular conference. That led to a 15+ year relationship with Kanuga, serving as chair of that conference, on the planning committee for that conference, and the Conference Planning Committee for the Board of Kanuga. It was a wonderful and fulfilling volunteer job. Eventually, and since they could not get rid of me, they offered me the position of Director of Adult Conferences, a position I held from 2012-2017. During those years, I met and worked with many wonderful people across the U.S. – and beyond.



I participated in many different worship experiences with many different bishops and priests. A highlight was getting to know Fr. Anthony Guillen, who has done much for Hispanic Episcopalians. In 2016, Kanuga hosted 416 individuals for the conference he chaired. That was a challenge! I was also instrumental in forming a partnership with the Episcopal Church Foundation to co-sponsor the Church Leadership Conference at Kanuga.

Norma Nesbitt Givens is a member of Christ Church Episcopal in Greenville, South Carolina. Norma was baptized September 1957 at Maple Creek Missionary Baptist Church in Greer, South Carolina. In 1970 she began her 40-year teaching career in higher education at Voorhees College, Denmark, South Carolina where she was introduced to the Episcopal Church. Voorhees College supported Norma's doctoral studies at the University of Georgia where she completed her degree in 1977. In 1979 Norma accepted an Administrative/Teaching position at Fort Valley State University in Fort Valley, Georgia. It must be noted that Fort Valley State was once supported by the Episcopal Church.

1993 Norma joined St. Luke's Episcopal Church, Fort Valley, Georgia. During her tenure at St. Luke's, Norma served in the following capacities: Interim Organist, Lay Reader, Secretary to the Vestry, Senior Warden, and a Deputy to the Diocesan Council of the Diocese of Atlanta. Bishop Neil Alexander appointed Norma to the following: an Ad Hoc Committee on Same Sex Blessing, Commission on Ministry, and Commission on Education. In 2012 and 2015 Norma was elected as a Deputy to the National Convention from the Diocese of Atlanta. At the 2015 National Convention Norma was elected to the General Board of Examining Chaplains. At Christ Church, currently Norma serves as a Lay Eucharistic Minister and a Lay Eucharistic Visitor, a member of the following committees: Worship and Liturgy and Faith in Action. Previously Norma was a member of the Third Century Commission, Bicentennial Celebration Committee, and a Delegate to the Diocesan Council meeting of the Upper Diocese of South Carolina. Norma is most proud to have been the first African American elected to the Vestry of Christ Church. Norma encouraged the Rector to invite the Greenville Chapter of Delta Sigma Theta Sorority to celebrate its Founders Day, January 12, 2020, during the 10:30 a.m. worship service and over 100 members of my sorority attended. Together we sang "Lift Every Voice and Sing."



### Ms. Grace Keller



I am a "cradle Episcopalian" and was born in Beaufort, SC, and baptized and confirmed at St. Helena's (formerly Episcopal) Church. My father was a Marine, so my family traveled with him. We were members of St. Christopher's Episcopal Church, Kailua, HI, St. James' Episcopal Church, Indian Head, MD, and back to St. Helena's. When my father retired, we moved to Mercersburg, PA, where he taught History at The Mercersburg Academy. There was no Episcopal Church in the town, so we attended the non-denominational services held at the Academy Chapel.

My education was varied as my first six years of school were in several Department of Defense schools. When we relocated to PA, I attended 7th and 8th grades at the local Jr./Sr. High

School. In ninth grade, I attended the National Cathedral School in Washington, DC, followed by my final three years of undergraduate education at Linden Hall School for Girls, Lititz, PA. This was a Moravian school, so everyone attended the Moravian services at the Moravian Church on campus. In my senior year, I arranged for all the Episcopalian girls to attend St. James' Episcopal Church in Lancaster, PA, once per month.

After graduation, I attended Ursinus College in Collegeville, PA, and then completed my college years at the University of South Carolina, Columbia, SC, majoring in Business. I worked for others for many years, and then in 1988, I started a small corporation named Creative Outdoor Designs and manufactured playground equipment. Our biggest customer was the Department of Defense, so I could travel to bases around the globe, selling and installing our playground equipment. In 1999, we ceased the manufacturing operations, and the company became a factory representative for a national playground equipment and park amenities firm.

I was able to broaden my client scope to include international schools worldwide in addition to the Department of Defense. In 2013, I closed the business to try my skills in other trades after moving from the Columbia, SC, metro area, where I had lived for 41 years, to Spartanburg, SC.

As an adult, I was a member in good standing at St. Alban's, Lexington, St. Francis of Assisi, Chapin, and now at St. Matthew's, Spartanburg, where I am the Senior Warden and a Daughter of the King. I sing in the Choir and chair the Network of Care Team and Stewardship Campaign team. I restart the Invite-Welcome-Connect ministry after Covid and am a Lector, Eucharistic Minister, and Eucharistic Visitor, and I am a member (of 8) of our Asylum Seeker Team. In addition, I volunteer in the Food Pantry ministry and do whatever is asked of me. I am also a Cursillista from EDUSC. In 2020, I graduated from Education for Ministry.



At St. Margaret's Episcopal Church, Boiling Springs, SC, I am the Parish Administrator. My duties include but are not limited to checking behind the Church Tellers, depositing money, keeping the roster up to date, preparing the weekly Service Bulletins, putting together the monthly Newsletter, and many other duties. I think this is my favorite and most rewarding job I have ever had in my life.

### The Reverend Patricia Sexton



The Rev. Patricia Sexton has been the Rector of All Saints' Cayce for eleven years. She holds a bachelor's degree in Philosophy, a Juris Doctor degree in Law, and a Master in Divinity (from Virginia Theological Seminary). Before becoming a priest, Patricia practiced law for seventeen years in the U.S. Virgin Islands and Boston, Massachusetts, and was a High School Humanities teacher and Administrator at a private K-12 school in Boulder, Colorado.

She has served in the diocese as Dean of the Midlands Convocation, member of the Commission on Ministry, DEC member, DEC Vice-President and President, Safe Church Trainer, and member of the Nominating Committee for the IXth Bishop of Upper SC. She is very interested in the work of the Disciplinary Board and believes that her experience as a priest as well as her life experience will be helpful in participating in the work of the Board.

## The Reverend Debbie Adolpo



Debbie found her way to ordained ministry after years of executive management in the not-for-profit advocacy arena in Washington, DC, where she and her family lived for twenty-five years.

In 2000 Debbie was accepted into the process of ordination in the Diocese of Virginia. She attended Virginia Theological Seminary in Alexandria, VA, and earned the degree of Master in Divinity in 2003. She was ordained to the Sacred Order of Priest in December of that same year.

In August 2003, Debbie was called to St. Francis in the Fields Episcopal Church, Louisville, KY (Diocese of Kentucky), as



Associate Rector for Discipleship. She served there with multiple job descriptions for eleven years. In the Diocese of Kentucky, she served a term on the Diocesan Executive Council and was appointed to the Commission on Ministry for seven years.

# The Reverend Marie Cope



The Rev. Marie Cope currently serves as the Priest Associate at St. Peter's, Greenville. After growing up in the Asheville area, I attended Furman University, where I became involved in Upper South Carolina's Peer Ministry program and served on the Commission for Young Adult Ministries. Prior to my studies at Virginia Theological Seminary, I worked at the Mental Health Association as a Crisis Intervention Specialist on CrisisLine. As a seminarian, I grew to love hospital chaplaincy, focusing my work in the Behavioral Health and Emergency Departments. Ordained in Western NC in 2002, I served as the Assistant Rector in several parishes. On the diocesan level, I was a Fresh Start facilitator, on the Camp Henry Board, and on the Episcopal Nominating Committee. As an ex-pat in Munich, Germany, I began the first EFM program in continental Europe through EFM-UK. Since then, I have served as a Deputy to General Convention (2022), as a Happening Spiritual Director, and on the Ecclesiastical Disciplinary Board.

As the Assistant Rector, having walked alongside a parish whose rector was inhibited due to Title IV violations, I am familiar with parish trauma and the many ripples of hurt and heartache that clergy misconduct produces. The clergyperson's family, parish staff and leaders, fellow clergy, and the clergyperson themselves need direct pastoral care and support as they grieve and search for a way forward, all the while not demonizing the individual whose choices have had devastating consequences. I hope to continue to be a compassionate presence to all involved.

### Jim Knubel



James (Jim) Knubel was born and raised with his three siblings in New Jersey. After graduating from River Dell High School, he attended the United States Naval Academy in Annapolis, Maryland. Jim graduated in 1969 and received his commission as an ensign in the Navy. Next, he attended Naval Nuclear Power School and Submarine School. He was assigned to the nuclear submarine USS DACE (SSN 607). Over the next several years, he held several key positions on the submarine and participated in several important missions. Jim left the Navy in 1974 to pursue a career in the civilian nuclear power industry.

During his career, he held some interesting and exciting jobs. The most notable ones were that he was site Vice President at the Three Mile Island

Nuclear Power Plants and became Vice President & Chief Nuclear Officer for the New York Power Authority.

Jim was widowed in late 2021. He has two grown children from a previous marriage and three grandsons. He moved to York, SC, in 2008 and joined Good Shepherd in 2013.

### EXECUTIVE SUMMARY OF AMENDMENTS TO CANONS OF THE EPISCOPAL DIOCESE OF UPPER SOUTH CAROLINA PROPOSED BY THE COMMITTEE ON CONSTITUTION AND CANONS

August 25, 2022

### INTRODUCTION

The Committee on Constitution and Canons is proposing a number of amendments to the Canons of the Episcopal Diocese of Upper South Carolina as adopted by the 95<sup>th</sup> Diocesan Convention November 4, 2017, as amended by the 96<sup>th</sup> Diocesan Convention November 3, 2018 and the 97<sup>th</sup> Diocesan Convention November 9, 2019 (the "Canons"). This Executive Summary sets forth the text of the proposed amendments marked to show changes from the provisions currently in effect, and a brief explanation of the reasons for the proposed amendments.

The primary issue the Committee seeks to address is the difficulty the Diocese had in establishing a clergy quorum for the 2021 Special Convention to Elect the Ninth Bishop of the Episcopal Diocese of Upper South Carolina. The current canonical requirement for a clergy quorum for an episcopal election is two-thirds of all clergy canonically resident in the Diocese and entitled to vote. Although a significant contributing factor to the difficulty in establishing a clergy quorum was the failure of an unusually large number of non-retired clergy to attend, the problem was exacerbated by the fact that all retired clergy had to be included in the clergy quorum calculation. An increasing number of retired clergy are in poor health, have mobility issues, or have moved out of the Diocese, which makes their ability to attend diocesan Conventions more difficult. In light of the aging population of clergy canonically resident in the Diocese, the number of retired clergy is likely to increase substantially over the next five to ten years. Accordingly, the Committee on Constitution and Canons proposes to amend the provision of the Canons relating to clergy quorum for an episcopal election by reducing such quorum from two-thirds to a majority of clergy canonically resident in the Diocese.

Additionally, the Committee has identified a few other provisions of the Canons that are unclear or ambiguous, and has proposed suggested amendments to those as well.

<sup>&</sup>lt;sup>1</sup> In recognition of these issues with the retired clergy, the amendments to the Canons adopted by the 95<sup>th</sup> Diocesan Convention in 2017 excluded retired clergy from the quorum calculation for an Annual Convention. Title I, Canon 4, Section 1(a). However, recognizing the importance of the wise counsel and spiritual guidance of the retired clergy, who, over their time of active service, have helped nurture and mold diocesan life, the Committee very deliberately proposed, and the 95<sup>th</sup> Diocesan Convention agreed, that retired clergy should continue to be included in the quorum requirement for the deliberations and ultimate decision about the most important event in the life of the Diocese, the calling of a bishop. Unfortunately, at that time, the Committee did not foresee the significant increase in the number of retired clergy over the next several years.



### PROPOSED REVISIONS AND EXPLANATIONS

### 1. <u>Title I, Canon 4, Section 1(d) – Episcopal Elections.</u>

As explained below, the Committee proposes a mathematical calculation that will accomplish the same numerical goal for election of a bishop as the current requirement even if few retired clergy attend.

Assume, for the sake of illustration, that there are 100 members of clergy canonically resident in the Diocese. Under the current canon, at least 67 of them must attend a Convention for an episcopal election to constitute a quorum, and a majority of those (34) must vote for a winning nominee. Under the Committee's proposal, only 51 clergy members would have to attend, and a nominee still would need a majority of the votes cast. However, the nominee could not be elected with just 26 votes because the proposal includes a dual requirement that the winner receive the votes of at least one-third of the clergy who are canonically resident in the Diocese. In this illustration, that would be 34 of the 100 clergy – the same as the current requirement.

The Committee also proposes moving the quorum requirements closer to the beginning of the canon.

### Text of Proposed Amendment

(d) Episcopal Elections. In the election of a Bishop, Bishop Coadjutor or Bishop Suffragan, the vote shall be by secret ballot, and by orders. At least a majority of all Clergy canonically resident in the Diocese and entitled to vote and Lay delegates from at least two-thirds of the Parishes and Missions of the Diocese entitled to representation and to vote shall constitute a quorum. The vote of each Lay delegate and of each Clergy member of Convention entitled to vote shall be counted as one vote. A concurrent majority of the two orders counted separately shall be necessary to elect, but in no case shall the Clergy vote constitute fewer than one-third of the total number of Clergy canonically resident in the Diocese. Nominations of any qualified Clergy may be made at any time during the balloting from the floor by process of writing in such name on a ballot. In such an election, at least two-thirds of all Clergy canonically resident in the Diocese and entitled to vote and Lay delegates from at least two-thirds of the Parishes and Missions of the Diocese entitled to representation and to vote shall constitute a quorum.

### 2. Title I, Canon 3, Section 1(a) -- Notices.

Although this section requires the Secretary of Convention to give notice of Annual and Special Conventions, it does not currently state the notice periods. These periods are set forth in Title II, Canon 4, Section 3 under the duties of the Secretary, but the Committee thought it would be helpful to also state them in this section. The references to clergy, parish and mission are also proposed to be conformed to the language used in Title II, Canon 4, Section 3.



Text of Proposed Amendment

### SECTION 1. CALLING AND ORGANIZATION OF CONVENTION.

(a) <u>Notices</u>. Notice of the meeting of any Convention shall be given by the Secretary of Convention in a letter transmitted by mail to all Clergy <u>canonically resident</u> in the <u>Diocese</u> and to every Parish <u>vestry</u> and Mission <u>committee</u> in the <u>Diocese</u> in union with Convention. These letters shall contain a notice of the time and place of Convention, and, if it is a Special Convention called as provided in these Canons for a particular purpose, the letters shall specify that purpose. <u>Notice of an Annual Convention shall be given at least seven months prior thereto</u>, and notice of a Special Convention <u>shall be given at least six weeks prior thereto</u>. The letter to Clergy responsible for the administration of a Parish or Mission shall also contain the form of parochial reports and the form of certification for delegates and alternates, and such extracts from the Constitution, Canons and Standing Resolutions of the Diocese as relate to the election of delegates and alternates. The completed form of certification for delegates and alternates shall be filed with the Secretary of Convention not later than six months prior to the Annual Convention date, or thirty calendar days prior to a Special Convention date.

### 3. Title III, Canon1, Section 2(b).

The Committee proposes to clarify this section by adding the term ex officio.

Text of Proposed Amendment

(b) Other Diocesan Executive Council Members. The Bishop, Chancellor, Vice Chancellor, Treasurer, Assistant Treasurer, and the Deans and Lay wardens of the Convocations shall serve as <u>ex officio</u> members of the Diocesan Executive Council for the term during which they serve in such offices.

### 4. <u>Title III, Canon 2, Sections 2 and 3.</u>

Adoption of bylaws is set forth under both the responsibilities of the Diocesan Executive Council (4<sup>th</sup> bullet of Section 2) and the responsibilities of the Standing Committee (last bullet of Section 3). However, only the Standing Committee has authority to adopt Bylaws for Diocesan Executive Council and Standing Committee. Accordingly, the Committee proposes deleting the fourth bullet of Section 2 that refers to adoption of bylaws by Diocesan Executive Council.

5. <u>Title III, Canon 2, Section 3</u> -- Interim Legislative Authority of Standing Committee between Conventions

The third bullet point of this section provides that one of the responsibilities of the Standing Committee is as follows:



• To function as an interim legislative authority of Convention, performing such specific functions as are delegated to it by Convention, the Constitution, and these Canons. Such duties shall include administering the budget and financial resources of the Diocese as described in the Statement of Mission described in Title V, Canon 1.

This provision has historically been interpreted somewhat more broadly than it is written. The purpose of the provision is to authorise the Standing Committee to take necessary action to ensure that the business of the Diocese can continue to be conducted efficiently when unexpected matters requiring approval of Convention arise between Conventions. The Committee proposes to amend this provision as follows to clarify the broader interpretation, and to ensure checks and balances are in place to prevent improper use of such authority.

### Text of Proposed Amendment

- To function as an interim legislative authority of Convention, performing such specific functions as are delegated to it by Convention, the Constitution, and these Canons. Such duties shall include, but not be limited to, administering the business, and the budget and financial resources of the Diocese as described in the Statement of Mission described in Title V, Canon 1; provided, however, the Standing Committee shall have no authority to legislate with respect to any matter exclusively reserved by the Constitution or Canons to the legislative authority of Convention.
- 6. <u>Title III, Canon 2, Section 3 and Title VIII, Canon 10, Section 1</u> -- Interim Authority of Standing Committee to Authorise the Ecclesiastical Authority to Convert a Parish to Mission Status

The Committee proposes to adopt the following as a new bullet point to Title III, Canon 2, Section 3, giving Standing Committee interim authority to authorize the Ecclesiastical Authority to convert a Parish to Mission status. The Committee noted that there have been a number of occasions when, for the health of the congregation concerned, the Ecclesiastical Authority has deemed it prudent to reduce a parish to mission status on an emergency basis without the prior approval of Convention required by Title VIII, Canon 10, Section 1. In such instances, the Ecclesiastical Authority has convened a special meeting of the Standing Committee to seek interim approval to take such action, and the action has then been submitted for ratification or reversal to the next immediately succeeding Convention. The Canons do not currently expressly provide for this procedure, though the authority seems implied. The Committee's proposal provides appropriate checks and balances on both the actions of the Ecclesiastical Authority and the Standing Committee in the case of such emergency action.

### Text of Proposed Amendment

• Upon the failure on the part of a Parish to maintain the conditions for status as a Parish, to approve, on an interim basis, the Ecclesiastical Authority's placing the



Parish in Mission status; *provided, however*, such action shall be submitted for ratification or reversal to the next immediately succeeding Convention.

The Committee also proposes to add a parallel provision to Title VIII, Canon 10, Section 1, as follows:

Text of Proposed Amendment

### SECTION 1. FAILURE TO MAINTAIN CONDITIONS.

Failure on the part of a Parish to maintain the conditions for status as a Parish shall warrant the Ecclesiastical Authority, with the approval of Convention, in placing said Parish in the status of Mission. Under such conditions the Ecclesiastical Authority shall have the right to appoint a vicar. The Ecclesiastical Authority's placing a Parish in Mission status may be approved by the Standing Committee on an interim basis; *provided, however*, such action shall be submitted for ratification or reversal to the next immediately succeeding Convention.

### 7. Title VIII, Canon 9, Section 3.

This section currently only gives the deadline for certification of delegates to an Annual Convention. The Committee proposes to amend the section also to add the deadline for certification of delegates to a Special Convention as set forth in Title I, Canon 3, Section 1(a).

Text of Proposed Amendment

### SECTION 3. DUTY TO SEND DELEGATES TO CONVENTION.

It shall be the duty of every Parish or Mission in union with Convention to send delegates to every Convention. It shall be the duty of every Vestry and Mission Committee to forward to the Secretary of Convention, not later than six months prior to an Annual Convention date or thirty days prior to a Special Convention date, a certified list of the delegates and alternates elected to represent the Parish or Mission, in order to aid in preparing a list of members of Convention. Such list of delegates and alternates shall be accompanied by a certification, signed by the rector, vicar, secretary of the Vestry, or one of the wardens, in the following form:

**NOW, THEREFORE BE IT RESOLVED**, that Title VIII, Canon 9, Section 3 of the Canons of the Episcopal Diocese of Upper South Carolina be, and it hereby is, amended to include the deadline for certification of delegates to a Special Diocesan Convention, and thereby to read as follows:

### SECTION 3. DUTY TO SEND DELEGATES TO CONVENTION.

It shall be the duty of every Parish or Mission in union with Convention to send delegates to every Convention. It shall be the duty of every Vestry and Mission Committee to forward to the Secretary of Convention, not later than six months prior to an Annual Convention date or thirty days prior to a Special Convention date, a certified list of the delegates and alternates elected to represent the Parish or Mission, in order to aid in preparing a list of members of Convention. Such list of delegates and alternates shall be accompanied by a certification, signed by the rector, vicar, secretary of the Vestry, or one of the wardens, in the following form: .... [The remainder of this section shall remain unchanged.]

**Whereas**, the business session of the 99<sup>th</sup> Convention was abbreviated, and there was no opportunity for the Credentials Committee to present the Resolution from the floor; and

Whereas, recognizing the importance of the Resolution, at its meeting on December 11, 2021, the Standing Committee of the Diocese, acting as the interim legislative authority of Convention, adopted the Resolution on behalf of the 99<sup>th</sup> Convention; and

**Whereas**, the Standing Committee requests that the 100<sup>th</sup> Convention of the Episcopal Diocese of Upper South Carolina (the "100<sup>th</sup> Convention") ratify the Standing Committee's adoption of the Resolution on behalf of the 99<sup>th</sup> Convention, and that the 100<sup>th</sup> Convention adopt the Resolution as its own.

**NOW, THEREFORE, BE IT RESOLVED**, that the 100<sup>th</sup> Convention hereby ratifies the Standing Committee's adoption of the Resolution on behalf of the 99<sup>th</sup> Convention; and, further,

Subject: Honoring and thanking retired clergy of the Episcopal Diocese of Upper South Carolina who attended the Special Convention to Elect the Ninth Bishop of the Diocese

Whereas, the Episcopal Diocese of Upper South Carolina craves the wise counsel and spiritual guidance of our retired clergy, who, over their time of active service, helped nurture and mold our diocesan life; and

Whereas, as a reflection of this sentiment, the Committee on Constitution and Canons very deliberately proposed and the 95<sup>th</sup> Diocesan Convention in 2017 agreed that retired clergy should continue to be included in the quorum requirement for the deliberations and ultimate decision about the most important event in the life of our Diocese, the calling of our bishop; and

Whereas, we recognize that this requirement places a particularly high burden on retired clergy, some of whom have health and mobility challenges, some of whom no longer reside in South Carolina, and all of whom are deserving of the opportunity to enjoy their well-earned retirement; and

Whereas, this year's Special Convention to Elect the 9<sup>th</sup> Bishop of the Episcopal Diocese of Upper South Carolina was held in the midst of a once-in-a-century global pandemic that has taken its heaviest toll on our senior citizens, such that even our retired clergy who are fully vaccinated are at significantly increased risk of serious complications or death if they contract COVID-19; and

Whereas, despite extensive public-health precautions taken for the convention, the risk of an airborne infection can never be reduced to zero when 285 people gather in an enclosed space; and

Whereas, our quorum requirement meant that even if all 80 non-retired clergy were in attendance, it was still necessary for at least 24 of our retired clergy to participate in order to achieve a quorum; and

**And whereas**, 28 of our retired clergy participated in the Special Convention, an excellent turnout even in the absence of a pandemic.

# AMENDMENTS TO CONSTITUTION OF THE EPISCOPAL CHURCH SECOND READING TO BE MADE AT 81<sup>ST</sup> GENERAL CONVENTION (2024)

### 2022-A031 Amend the Constitution and Canons Relating to Mergers of Dioceses

Resolved, That the 80th General Convention amend Article V, Section 4 of the Constitution to read as follows:

Art.V

**Sec. 4.** Whenever a new Diocese is formed and erected out of an existing Diocese or out of two or more existing Dioceses or parts of them, the formation process of the newly formed Diocese, including the adoption of its Constitution and Canons, shall be as set forth in the Canons.

Resolved, That the 80th General Convention amend Article V, Section 4 of the Constitution to read as follows:

Art.V

**Sec. 4.** Whenever a new Diocese is formed and erected out of an existing Diocese *or out of two or more* existing Dioceses or parts of them, it shall be subject to the Constitution and Canons of the Diocese out of which it was formed, except as local circumstances may prevent, until the same be altered in accordance with such Constitution and Canons by the Convention of the new Diocese the formation process of the newly formed Diocese, including the adoption of its Constitution and Canons, shall be as set forth in the Canons.

Whenever a Diocese is formed out of two or more existing Dioceses, it shall be subject to the Constitution and Canons of that one of the said existing Dioceses to which the greater number of Members of the Clergy shall have belonged prior to the erection of such new Diocese, except as local

circumstances may prevent, until the same be altered in accordance with such Constitution and Canons by the Convention of the new Diocese.

### 2022-A059 Amend Article X of the Constitution of The Episcopal Church

Resolved, That the 80th General Convention of The Episcopal Church repeal Article X in its entirety and replace it with the following:

**Sec. 1.** The Book of Common Prayer is understood to be those liturgical forms and other texts authorized by the General Convention in accordance with this article and the Canons of this Church.

The Book of Common Prayer in this Church is intended to be communal and devotional prayer enriched by our church's cultural, geographical, and linguistic contexts. The Book of Common Prayer shall contain both public worship and private devotion.

The Book of Common Prayer, as now established or hereafter amended by the General Convention, shall be in use in all the Dioceses of this Church.

- **Sec. 2.** No alteration thereof or addition thereto shall be made unless the General Convention approve the same on first reading in one regular meeting of the General Convention and, by resolve so directing, be sent by the Secretary of the General Convention to the Secretary of the Convention of every Diocese, to be made known to the Diocesan Convention at its next regular meeting, and be adopted on second reading without alteration by the General Convention at its next succeeding regular meeting by a majority of all Bishops, excluding retired Bishops not present, of the whole number of Bishops entitled to vote in the House of Bishops, and by an affirmative vote by orders in the House of Deputies in accordance with Art. I, Sec. 5 of this Constitution, except that concurrence in the affirmative by the orders shall require the affirmative vote in each order by a majority of the Dioceses entitled to representation in the House of Deputies.
- **Sec. 3.** No alteration thereof or addition thereto shall be made unless it has previously been authorized for Trial Use in accordance with this Article and the Canons of this Church.
- **Sec. 4.** The General Convention may at any one meeting, by a majority of the whole number of the Bishops entitled to vote in the House of Bishops, and by a majority of the Clerical and Lay Deputies of all the Dioceses entitled to representation in the House of Deputies, voting by orders as previously set forth in this Article:
  - a. Amend the Table of Lessons and all Tables and Rubrics relating to the Psalms.
  - **b.** Authorize for Trial Use such alterations or additions in whole or in part to the established Book of Common Prayer as may be proposed in accord with the Canons of this Church and duly undertaken by and implemented according to the directives of the General Convention.
  - **c.** Authorize for use throughout this Church, as provided by Canon, alternative and additional liturgies to supplement those provided in the Book of Common Prayer.

**Sec. 5.** Nothing in this Article shall be construed as restricting the authority of the Bishops of this Church to take such order as may be permitted by the Rubrics of the Book of Common Prayer or by the Canons of the General Convention for the use of special forms of worship.

### 2022-A157 Amend Article I Sec. 7

Resolved, That Article I, Section 7 of the Constitution be amended to read as follows:

Sec. 7. The General Convention shall hold its regular meeting not less than once in each three years, at a time and place determined in accordance with the Canons. Special Meetings may be held as provided for by Canon.
